RECEIVING DATES: Sun. Nov 26th, 1-5pm and Mon. Nov.27th. 1-3pm at the KAA Gallery: Route 7, 21 South Main Street (just south of the traffic light), Kent, Connecticut. ALL WORK MUST BE HAND DELIVERED. (Please bring a recent copy of your bio for visitor reference.)

REMOVAL OF WORK: Work not accepted for exhibition may be picked up during exhibition hours. Exhibited work may be removed Sunday, Dec.17, 1-5pm. No early pick ups. Strictly adhered to!

AWARDS RECEPTION: Saturday, Dec. 2nd, 2-4pm Refreshments will be served.

ELIGIBILITY: Elected Artists ONLY. Dues for the current year must be paid. Oils, watercolors, encaustic, pastels, graphics, collage, acrylics, and small sculpture. NO work produced in a classroom setting. Paintings larger than 48" x 52" will be considered two paintings, (no painting shall exceed 60 inches in width or height). Sculpture must be free standing, limited to 50 lbs., and no larger than 36" in any direction.

Sculptors may supply their own professional quality pedestals/stands. In regard to prints, we accept wood blocks, linoprints, and hand-pulled prints 1 through 10, i.e. monotypes, etc. Wrap Around Canvas will be accepted for paintings on canvas. however, wrap-around canvases must have sides covered with a continuation of the painting itself around the edges. No staples should be visible when painting is hung. ALL WORKS MUST BE ORIGINAL AND

MAY HAVE BEEN PREVIOUSLY SHOWN AT KAA.

Portraits should show price of similar work. Sale price must include frame. Pictures must be framed and ready for hanging with screw eyes and wire. A limit of three entries per artist. We guarantee at least one piece will be hung. Every effort will be made to exhibit all entries. The Kent Art Association. Inc. reserves the right to reject any and all works of art submitted to its exhibition. Elected Artists may pay annual dues on receiving days.

AWARDS: Ridgewood Art Association \$100 Award of Excellence and two KAA \$100 Awards of Excellence

ENTRY FORM: All entries must have entry forms properly filled out and attached to back. (Attach to upper left corner of picture frame). PLEASE PRINT CLEARLY. DO NOT WRITE. SALES: A commission of 30% will be deducted from the purchase price of all sales.

ENTRY FEES: An entry fee of \$10 for one, two, or three pieces will be charged for this show A self-addressed envelope is NOT necessarv.
