

# 2010 Juried Spring Show

**DATE OF EXHIBITION:** April 18 through June 6.  
**LOCATION:** The Kent Art Association Gallery, Rte.7 South Main St, Kent, Connecticut.  
**RECEIVING DATES:** Friday, April 16, 1-4 pm or Saturday, April 17, 10am-1pm at the KAA Gallery, Route 7, 21 South Main Street (just south of the traffic light), Kent, Connecticut. ALL WORK MUST BE HAND DELIVERED. (Please bring a recent copy of your bio for visitor reference.)  
**REMOVAL OF WORK:** Work not selected for exhibition may be picked up during exhibition hours. Exhibited work may be removed Saturday, June 12, 10am-2pm. No early pickups. Strictly adhered to!  
**OPENING RECEPTION:** Friday, April 23, 5-7 pm.  
**AWARDS RECEPTION:** Saturday, April 24, 2-4 pm.  
**ELIGIBILITY:** Representational oils, watercolors, pastels, graphics, acrylics, small sculpture and collage. NO computer prints or photographs. Paintings limited to 42" X 42" overall size. Sculpture must be free standing, limited to 50 lbs., and no larger than 36" in any direction. In regard to prints, we accept wood blocks, linoprints, and hand-pulled prints, i.e. monotypes, etc. Wrap Around Canvas will be accepted for oils and acrylics on canvas. Wrap Around Canvas MUST have its sides covered with a continuation of the painting itself around the edges. No staples should be visible when the painting is hung. ALL WORKS MUST BE ORIGINAL, FOR SALE, and NOT PREVIOUSLY SHOWN AT THE KAA GALLERY. Portraits should show price of similar work. Sale price must include frame. Pictures must be framed and ready for hanging with screw eyes and wire. A limit of two entries per artist. The Kent Art Association, Inc. reserves the right to reject

any and all works of art submitted to this show irrespective of jury decision.  
**AWARDS:** Awards ceremony will be held at 3 pm on Saturday, April 24. The "Best in Show" and "First Place in Any Medium" awards may be won only once per year by the same artist. Changes and/or additions to awards may be listed in the catalog.  
**ENTRY FORM:** All entries must have entry forms properly filled out and attached to the back. (Attach to upper left corner of picture frame.) PLEASE PRINT CLEARLY. DO NOT WRITE.  
**SALES:** A commission of 30% will be deducted from the purchase price of all sales.  
**ENTRY FEES:** MEMBERS: \$20 for 1 or 2 pieces. NON-MEMBERS: \$30 for 1 piece; \$35 for 2 pieces. Entry fees are NOT refundable. Exhibitors will be notified of jury's decision. Notification slips must be presented to obtain works at time of pickup. A SELF-ADDRESSED STAMPED ENVELOPE MUST ACCOMPANY ENTRIES ON RECEIVING DAY.  
**RESPONSIBILITY:** The greatest possible care will be taken in handling works, but not KAA, Inc. nor any of its agents shall have any responsibility whatsoever for any loss or damage to any entry from any cause whether such entry shall be on display, in storage or in transit. Artists must carry their own insurance if deemed necessary. The Gallery requests the right to photograph work for the catalogue or press information. Submitting an entry to this exhibit implies agreement on the part of the sender with the conditions set forth above.

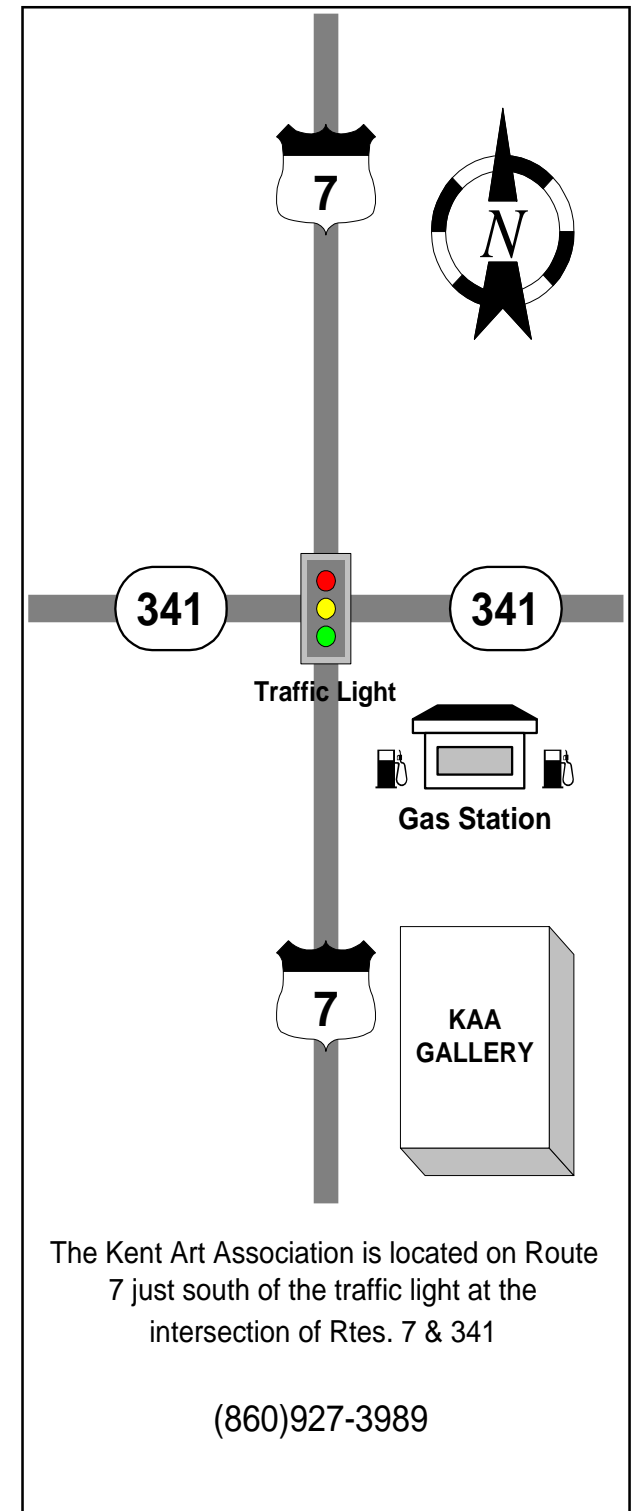
