RECEIVING DATES: September 11th, from 3-5; Saturday, September 12th, from 10-12 at the KAA Gallery, Route 7, 21 South Main Street (just south of the traffic light), Kent, Connecticut. ALL WORK MUST BE HAND DELIVERED. (Please bring a recent copy of your bio for visitor reference.)

REMOVAL OF WORK: Work may be removed on Sunday, October 4th from 12-3.

SHOW OPENS: Friday, September 18th.

OPENING RECEPTION & AWARDS: Saturday, September 19th from 4-6

ELIGIBILITY: Members ONLY. Dues for 2026 must be current. Representational and non-representational oils, watercolors, pastels, graphics, acrylics, small sculpture, mixed media, fiber arts, and collage. Photographs must be originals executed and altered by the photographer only.

We accept prints from woodblocks, linoprints, and monotypes. Wraparound canvas is acceptable for oils and acrylics but must have the sides painted with no staples visible. All unframed work must be exhibition ready and wired to hang.

All works must be original, current within the last three years and not have been previously shown at the KAA.

Sale price must include frame. Pictures must be framed and ready for hanging with appropriate hangars or screw eyes and wire.

Please fill out labels for each of your artworks and attach them to the back of your work.

The Kent Art Association, Inc. reserves the right to reject any and all works of art submitted to this show irrespective of jury decision.

ENTRY FORM: All entries must have consignment sheets properly filled out. Additionally, fill out a label for each of your works and attach it to the back.

PLEASE PRINT CLEARLY. DO NOT WRITE.

SALES: A commission of 30% will be deducted from the purchase price of all sales.

ENTRY FEES: MEMBERS: \$25.00 for up to 2 pieces.

RESPONSIBILITY: The greatest possible care will be taken in handling works, but not KAA, Inc. nor any of its agents shall have any responsibility whatsoever for any loss or damage to any entry from any cause whether such entry shall be on display, in storage or in transit.

Artists must carry their own insurance if deemed necessary.
