SELECTIONS: Sunday, May 5th at 12:00.
You will be notified if your work is not
selected. Judging will be held on Thursday,
May 9th.
MUST HAVE BEEN COMPLETED WITHIN
THE LAST TWO YEARS.

SHOW OPENS: Friday May 10th at 1:00.

OPENING RECEPTION: Friday, May 10th
from 6-8. Awards will be given out at 7:00.

REMOVAL OF WORK: Work may be
removed on Sunday, June 2nd from 12-2.

ELIGIBILITY: All artists may enter this show
regardless of membership status.

WORKS ELIGIBLE: Fabrics and fibers;
quilted, woven, felted or spun as sculptures
and wall displays; paper materials as
sculptures for wall and 3 dimensional
displays; natural materials as sculptures
and wall displays.

SIZE LIMIT: Maximum dimensions for wall
hangings is 42"x60"

As space is limited in this new invitational
and juried show, the selection process will
be highly competitive. Please submit your
best creative works to represent the fiber
arts community.

All works must be original, for sale, and not
previously shown at the KAA.

The Kent Art Association, Inc. reserves
the right to reject any and all works of art
submitted to this show irrespective of jury
decision.

ENTRY FORM: Please fill out entry form
and label for each of your artworks and
attach label to the back of your work.

PLEASE PRINT CLEARLY.

SALES: A commission of 30% will be
deducted from the purchase price of all
sales.

ENTRY FEES: Members – \$35 for up to 3
pieces. Non-members, \$50.00 for up to 3
pieces.
