ELIGIBILITY: All artists/photographers may enter this show.

WORKS ELIGIBLE: Original photographs only, color and black & white film and digital. Categories include but not limited to: Portraiture, Wildlife, Landscape, Still Life, Digitally Edited, Abstract. Works must be recent, original and not previously shown at KAA.

Photographs must be executed and edited by the photographer only. Pictures must be ready for hanging. Sale price must include frame if used. All works must be original, for sale, and not previously shown at the KAA. Please fill out labels for each of your artworks and attach them to the back of your work.

The Kent Art Association, Inc. reserves the right to reject any and all works of art submitted to this show irrespective of jury decision.

ENTRY FORM: Please fill out entry form and label for each of your artworks and attach label to the back of your work. PLEASE PRINT CLEARLY.

SALES: A commission of 30% will be deducted from the purchase price of all sales.

ENTRY FEES: Members – \$35 for up to 3 pieces. Non-members, \$50.00.
